PUBLIC COMMENT

New Fire Truck presentation by the Fire Department - Fire/EMS Committee and Spencer Manufacturing.

- Board members went outside where the fire department gave an overview of the differences between the current vehicle and the proposed new truck.
- Questions were asked by board members and answered by Firefighter Dan Miller and Grant Spencer of Spencer Fire Trucks in South Haven.
- The proposed truck will be in compliance with current standards and should be good for at least the next twenty years with proper maintenance.
- Ballpark figure for the value of the current truck is \$40,000 to \$80,000. The plan is to sell it after delivery if the new vehicle is approved. It would be possible to use it as a trade-in with Spencer but that would be decided upon at a later time.
- The cost of the truck is \$754,954 from Spencer which was the recommendation by the Fire Committee.
- Payment options were reviewed.
  - o If the prepayment issue is chosen, a performance bond would need to be

- Spencer proposed a \$20,000 contingency fund to allow for changes as the truck is being built. Any amount not used would be refunded at the end of the build process.
- The board discussed that the prepayment does not seem to be the best option as it doesn't save that much money and costs the township in interest earnings.

Motion by Cunningham with support from VanHouten to make a total of up to \$754,954 in payments for the new Pumper using funds from the Fire Equipment Purchase Fund, ARPA Funds, and the 2022/2023 and 2023/2024 fiscal year General Fund Budgets with no financing required. Discussion: The main point here is that there is no financing here. The funds from 2023/2024 may not be needed. If the old truck is sold that would help cover the cost of modifications. Roll Call Vote: Mousseau: yes; Knowles: yes; VanHouten: yes; Cunningham: yes.

MOTION REGARDING FUNDS USED TO MAKE PAYMENTS

Motion by Cunningham with support from Mousseau to approve up to \$45,000 in additional accessory equipment and modifications to the new pumper required for it to be fully operational. All of the additional \$45,000 in additions to be individually approved by the YST Board of Trustees. Discussion: This doesn't mean that all of that amount will be spent. It means that the Board is willing to go up to that amount but will still require approval. Spencer does not believe that this would cause any delay in production. Any change order with Spencer will be at the cost of the equipment; they do not charge a change order fee. Equipment does not have to be purchased through Spencer. Roll Call Vote: Cunningham: yes; VanHouten: yes: Mousseau: yes; Knowles: no.
